



# SIRENS CONFIDENTIALITY AGREEMENT

This Confidentiality Agreement ("Agreement") is made between Sirens Athletics Inc. ("The Sirens") and \_\_\_\_\_ ("The Player"). This Agreement is effective upon signing.

The Sirens are providing the opportunity for women to play Professional Football. The Player is engaged in playing football and representing the team. The Player agrees to maintain the confidentiality of all documents, verbal and written disclosures, staffing, financial information, football operations in general and any other information pertaining to The Sirens which may be disclosed to them. The parties agree as follows:

**CONFIDENTIAL INFORMATION.** The term "Confidential Information" means any materials or information which is proprietary to The Sirens, whether or not it is owned or developed by The Sirens, which is not generally known by others than The Sirens, and which The Player may obtain through any direct or indirect contact with The Sirens.

Includes without limitation:

business and financial records and plans, financial statements, trade secrets, customer lists and records, technical information, products, inventions, product design information, pricing structure, discounts, source codes and/or object codes, costs, computer programs and listings, copyrights and other intellectual property, plays, other proprietary information.

Confidential Information also pertains to any of the above information regarding the Independent Women's Football League, its representatives and operations.

**PROTECTION OF CONFIDENTIAL INFORMATION.** The Player understands and acknowledges that the Confidential Information has been developed or obtained by The Sirens by the investment of significant time, effort, or expense; and that the Confidential Information is a valuable, special and unique asset of The Sirens which provides The Sirens with a significant advantage; and needs to be protected from improper disclosure. In consideration for the disclosure of the Confidential Information, The Player agrees to hold all such information in confidence and not disclose such information to any person or entity without prior written consent of The Sirens. In addition, The Player agrees that

1. No copying/Modification. The Player will not copy or modify and Confidential Information without prior written consent of The Sirens.
2. Unauthorized Disclosure of Confidential Information. If it appears that The Player has disclosed (or has threatened to disclose) Confidential Information in violation of this Agreement, The Sirens shall be entitled to an injunction to restrain the Player from disclosing, in whole or in part, any Confidential Information. The Sirens shall not be prohibited by this provision from pursuing any and all other remedies, including a claim for losses or damages.

**RETURN OF CONFIDENTIAL INFORMATION.** Upon written request of The Sirens, The Player shall return to The Sirens all written materials containing Confidential Information. The Player shall also deliver to The Sirens written statements signed by The Player certifying that all materials have been returned within five (5) days of receipt of the request.

**GENERAL PROVISIONS.** The Agreement sets forth the entire understanding of the parties regarding confidentiality. Any amendments must be in writing and signed by both parties. The Agreement shall be construed under the laws of the State of California and shall not be assignable by either party. Neither party may delegate its duties under this Agreement without prior written consent of the other party. The confidentiality provisions of this Agreement shall remain in full force and effect once signed.
